**ORDER OF
PROTECTIVE SUPERVISION
(Assigned Judge *&COMMENT1)**

TO THE JUVENILE NAMED ABOVE:

IT IS ORDERED that you are placed on Protective Supervision until _____, 20____; or until your 18th birthday, under the control and supervision of the Yuma County Juvenile Probation Department, with the following conditions:

- _____ 1. You will obey all laws, including all city, county, state and federal laws, and notify your probation officer of any type of contact with law enforcement officers within 24 hours.
- _____ 2. You will obey the reasonable rules and requests of your parent(s) or legal guardian(s) and school officials.
- _____ 3.
 - a. You will not associate with any juvenile or adult who is on probation; protective supervision or parole.
 - b. You will not associate with any gang member, participate in gang related activities, or wear or display gang-related logos, clothing or paraphernalia identifying gang membership.
- _____ 4. You will register for school and attend school on a regular basis. It is your responsibility to notify your probation officer of any changes in your school status:
 - a. If absent, you will notify your probation officer by 8:30 a.m. the same day of the absence.
 - b. If absent because of illness two or more days, you will deliver a copy of a doctor's note to the probation officer. The doctor's note will be from a physician or school nurse practicing in the United States.
 - c. You shall obey the reasonable rules and requests of school officials. Some of these rules include that you shall be required to respect staff and other students, you will not engage in physical confrontations or start fights, you will not deface any school property and you will not engage in behavior that results in the suspension and/or expulsion. If you are suspended or expelled, you must immediately notify your probation officer.
- _____ 5. You will not be away from home between the hours of () 6:00 p.m. or () 9:00 p.m. and 6:30 a.m., without the permission of your parent(s) or legal guardian(s) and without their knowing your exact destination and exact hour of return.
- _____ 6. You will not leave Yuma County for more than 24 hours without prior authorization from your probation officer. You must submit a request 48 hours in advance of the day that you want to leave.
- _____ 7. You will notify your probation officer prior to moving or changing your telephone number.
- _____ 8. You will report to your assigned probation officer, and report as directed on the _____
_____. In addition, random and unannounced visits will be made to your home each month.

- _____ 9. You will not own or possess any deadly weapon or firearm.
- _____ 10. You will not use, possess or consume alcoholic beverages or mind altering substances, including beer and wine, marijuana, dangerous drugs, narcotics, intoxicating substances, toxic vapors or unregulated synthetic compounds such as Spice or bath salts.
- _____ 11. You will submit to urinalysis as directed by your probation officer.
- _____ 12. You will participate in, cooperate with and complete any program including, medical, mental, vocational or educational treatment or training programs as directed by the Court or your probation officer, and you will not terminate such programs without the prior approval of the Court or your probation officer. Such program(s) shall include the following:

- _____ 13. Pursuant to A.R.S. 8-241(A), the parent(s) or legal guardian(s), and the juvenile are hereby assessed a protective supervision fee of \$60.00 per month, for each month until the juvenile is released from protective supervision by further Court order. The parent(s) or legal guardian(s), and the juvenile are ordered to pay this amount on the juvenile's report day of each month. The juvenile is expected to repay the parent(s) or legal guardian(s), if they pay the monthly fee. If you become 60 days delinquent on your probation fees, a probation violation may be filed.
- _____ 14. Pursuant to A.R.S. 8-234(D), the parent(s), legal guardian(s) or juvenile are hereby assessed \$ _____ treatment fee for each referral, including counseling and/or educational classes until the juvenile is terminated from protective supervision by further Court order.
- _____ 15. Other special conditions as follows:

II. PARENTAL ACKNOWLEDGMENT OF CONDITIONS OF THE JUVENILE'S PROTECTIVE SUPERVISION AND PARENTAL RESPONSIBILITIES:

Pursuant to A.R.S. 8-235, the Court finds that an Order of Disposition has been made concerning the above-named juvenile and that the proposed conduct of this parent(s) or legal guardian(s) may assist in the rehabilitation of the juvenile. It is proposed that the parent(s) or legal guardian(s) comply with the following:

1. You will cooperate in any treatment plan and the implementation of the terms of protective supervision.
2. You will promptly report any violation of my child's protective supervision to the Juvenile Probation Department.
3. You will report to your child's probation officer by 8:30 a.m. the same day your child misses school.
4. You will provide a doctor's note to the Juvenile Probation department, if your child is out sick from school for more than two (2) days.
5. You will provide transportation for your child to participate in protective supervision activities and programs when necessary.
6. You will enroll your son/daughter in school prior to each school session or as of _____, 20__.
7. You will notify the Juvenile Probation Department of changing your place of residence or telephone number.
8. You will wake your child for school, make sure he/she is ready and see to it that he/she juvenile meets the school bus each morning, or that other transportation is arranged for him/her to get to school.
9. Pursuant to ARS 8-241(A), you will pay a monthly protective supervision fee of \$60.00.
10. You will allow and release information to be provided to the juvenile probation department by all school officials.

You have the right to a hearing before any Court Order is issued commanding you to do these things. However, you may agree to a Court Order without a hearing.

_____ I agree to do these things and the Court may issue an Order without a hearing commanding me to do these things. I understand that if I fail to follow the Court's order, I may be held in contempt and be fined or put in jail.

_____ I do not agree to do these things, and I want a hearing before the Court before any such Order is issued.

I have received and understand the rules and terms of my child's Order of Protective Supervision. I also understand that I will pay a monthly supervision fee as per state law and this Court order. I acknowledge that I will cooperate in any treatment plan and this Court order. I also understand that failure to comply with this Court order, encouraging violations of this Order or through my actions or inactions causing my child to violate this Court order may result in appearance before the Judge of the Juvenile Court on an Order to Show Cause for contempt of Court, and I may be severely punished. This punishment can range from up to 30 days in jail and/or up to a \$1,000.00 fine.
