**WHEREAS:** pursuant to Arizona Revised Statutes 11-251.08, a Fee Schedule is currently in effect for the Humane Society of Yuma, and

**WHEREAS:** the Yuma County Board of Supervisors has provided public notice and conducted a public hearing as required by Arizona Revised Statutes 11-251-08.C:

Unaltered dog 4 months or older	\$25.00
Altered dog 4 months or older	\$13.00
Duplicate License (unaltered)	\$12.00
Duplicate License (altered)	\$ 8.00
*Visitor License	\$ 6.00
*(Proof of vaccination and current license in home state)	
*Penalty fee after March 31 <sup>st</sup>	\$ 4.00/monthly
*((\$36 maximum in addition to applicable license fee)




