21 Stephen J. Rouff and the Honorable Lisa W. Bleich, shall be assigned based on the
22 numbering system below.

24 (1) All numbered cases, the last digit of which number is "0", "1", "2" or "3" shall
25 be assigned to Division Two, The Honorable John Paul Plante.

27 (2) All numbered cases, the last digit of which number is "4" or "5" shall be
28 assigned to Division Six, The Honorable Maria Elena Cruz.

1 (3) All numbered cases, the last digit of which number is "6" or "7" shall be
2 assigned to Commissioner Two, The Honorable Stephen J. Rouff.

3 (4) All numbered cases, the last digit of which number is "8" or "9" shall be
4 assigned to Commissioner Three, The Honorable Lisa W. Bleich.

5 Notwithstanding the foregoing judicial assignments, during the absence or
6 unavailability of any Superior Court Judge or Commissioner/Pro Tem, another
7 Superior Court Judge or Commissioner/Pro Tem may be substituted in his or her
8 place.
