RESOLUTION NO. 2016-27

A JOINT RESOLUTION OF YUMA COUNTY (COUNTY) AND THE YUMA COUNTY FLOOD CONTROL, PUBLIC HEALTH SERVICES DISTRICT, JAIL DISTRICT, FREE LIBRARY DISTRICT, IMPROVEMENT DISTRICTS & SPECIAL DISTRICTS ADOPTING THE COUNTY BUDGET FOR FISCAL YEAR 2016-2017.

WHEREAS: In accordance with the provisions of A.R.S. §§ 42-17101 et seq., and 48-3620, on May 16, 2016, an estimate was made of the amounts required to meet the public expenditures for the ensuing fiscal year, and

WHEREAS: Publication has been duly made, as required by A.R.S. § 42-17103, of said estimates, together with a notice that the Board of Supervisors (hereinafter "Board") will hold a public hearing for the purpose of hearing taxpayers at the designated time and place, and

WHEREAS: In accordance with A.R.S. §42-17104, the Board met on June 20, 2016, at which meeting any taxpayer was privileged to appear and be heard in favor or against any of the proposed expenditures or tax levies, including concerns regarding the secondary property tax levies, and

WHEREAS: The sums to be raised by taxation, as specified in the estimates published in the manner described herein, do not in the aggregate amount exceed that amount as computed in A.R.S. § 42-17051, or in HB2876, and

WHEREAS: The primary property tax levies set forth in the FY 2016-2017 budget which is the same as the prior year levy plus new construction can be achieved with an increase in the primary property tax rate from \$2.4132 to \$2.4684, and

WHEREAS: The combined secondary tax levies set forth in the FY 2016-2017 budget can be achieved by decreasing the FY 2016-2017 combined secondary property tax rates from \$1.1772 to \$1.1769, and

WHEREAS: The assessments charged in a number of improvement districts are being changed from the FY 2015-2016 fiscal year in order to adequately cover improvement district fiscal year 2016-2017 estimated expenditures and meet appropriate fund requirements,

WHEREAS: Salary and benefit changes that go into effect in the 2016-2017 fiscal year, subsequent to approval of a Resolution No. 2016-26.

1. **Fiscal Year 2016-2017 Budget:** The statement of Revenues and Expenditures prepared for fiscal year 2016-2017, on the forms provided by the State Auditor General and presented to the Board on June 20, 2016, along with the textual and other changes to the fiscal year 2016-2017 Recommended Budget required as a result of the Board's actions and other changes as listed on attachment, subsequent to the Recommended Budget's presentation, and hereby adopted as the fiscal year 2016-2017 final budget.
2. **Capital Improvement Plan (CIP):** The CIP document prepared for fiscal year 2016-2017, along with textual, project, and other changes to the fiscal year 2016-2017 CIP as a result of the Board's actions subsequent to the Recommended CIP's presentation and other changes as listed on attachment, are hereby adopted as the fiscal year 2016-2017 CIP.


