APPOINTMENT OF THE
ASSOCIATE PRESIDING JUDGE

Pursuant to Rule 92 of the Arizona Supreme Court, the Presiding Judge in each county, in addition to exercising general administrative supervision over the court and the judges thereof, shall appoint, with the approval of the Supreme Court, an Associate Presiding Judge to act in place of the Presiding Judge during the absence or unavailability of the Presiding Judge. After due consideration,

IT IS ORDERED that, subject to the approval of the Arizona Supreme Court, the Honorable Roger A. Nelson is appointed Associate Presiding Judge of the Superior Court in Yuma County effective upon the approval of the Arizona Supreme Court. Judge Roger A. Nelson shall serve in such capacity of Associate Presiding Judge at the pleasure of the Presiding Judge of the Superior Court in Yuma County and shall exercise and discharge all the powers of the Presiding Judge, except that he may not appoint Court Commissioners or appoint Judges permanently to special assignments.
