WHEREAS: Pursuant to Arizona Revised Statutes 11-251.08, a Fee Schedule is currently in effect for the Humane Society of Yuma, and

WHEREAS: The Yuma County Board of Supervisors has provided public notice and conducted a public hearing as requested by Arizona Revised Statutes 11-251-081.C:

NOW, THEREFORE, BE IT RESOLVED, that the Yuma County Board of Supervisors adopts revisions to the Fee Schedule which supersede all previously adopted fee schedules:

Rabies Control License

Unaltered dog 3 months or older	\$25.00
Altered dog 3 months or older	\$13.00
Duplicate License (unaltered)	\$12.00
Duplicate License (altered)	\$ 8.00
*Visitor License	\$ 6.00
*(Proof of vaccination and current license in home state)	
*30 days after license expires	\$ 4.00/monthly
*(\$36 maximum in addition to applicable license fee)	

Animal licenses are valid for 12 months, unless anti-rabies vaccine expires earlier




