
APPOINTMENT OF CARLY M.

MASTER FOR THE BENEFIT OF ALL
YUMA COUNTY COURTS

Pursuant to Arizona Rules of Criminal Procedure 1.7(d), Arizona Code of Judicial Administration §1-305, and the Administrative Orders of this Court, the written request and approval of the Hon. Gregory S. Stewart, presiding judge of the Justice of the Peace Courts in Yuma County, and that the selection procedures for this part-time position of Initial Appearance Master have previously been met,

IT IS ORDERED that Carly M. Sandoval is appointed Initial Appearance Master for the benefit of all Yuma County Courts, in the manner provided in Arizona Rules of Criminal Procedure 1.7 from July 23, 2018 through June 30, 2019, to conduct initial appearances for all Yuma County courts on weekends and holidays and which duties and responsibilities are at the direction and control of the Presiding Justice of the Peace in Yuma County.

IT IS FURTHER ORDERED that Carly M. Sandoval shall be compensated for the service provided by this appointment as provided for in the Rules of Criminal Procedure, and that such compensation will be set by the Presiding Justice of the Peace.
