AMENDING THE YUMA COUNTY TAX DEEDED PROPERTY  
AUCTION POLICY

**WHEREAS:** The Board of Supervisors is authorized pursuant to A.R.S. §42-18301 et. seq. to conduct a public sale of real property in the county that is held by the State by tax deed ("Tax Deeded Property Auction"); and

**WHEREAS:** The Board of Supervisors desires to delegate the conduct of the auction, and all statutory requirements leading up to the sale, to the Yuma County Clerk of the Board; and

**WHEREAS:** The Board of Supervisors desires to make this delegation effective until rescinded by the Board of Supervisors; and

**WHEREAS:** The Board of Supervisors hereby appoints the Yuma County Clerk of the Board as its agent to comply with the statutory requirements and to conduct the Yuma County Tax Deeded Property Auction; and

**WHEREAS:** This County Tax Deeded Property Auction Policy and Procedure supersedes all other Tax Deeded Property Auction procedures previously adopted.

**NOW, THEREFORE, BE IT RESOLVED,** that the Tax Deeded Property Auction shall be conducted at such time and place as determined by the Yuma County Clerk of the Board in accordance with the amended policy and procedure adopted herewith.
