Pursuant to Rule 92 of the Supreme Court, the Presiding Judge in each county, in addition to exercising general administrative supervision over the court and the judges thereof, shall make regular and special assignments of all judges.

The Honorable Kathryn Stocking-Tate shall serve in the capacity of Juvenile Court Presiding Judge at the pleasure of the Presiding Judge of the Superior Court in Yuma County and shall exercise and discharge all the lawful powers of the office of Presiding Judge of the Juvenile Court of the Superior Court in Yuma County.
