## Yuma County Public Health District Update

Yuma County Health Officials confirm 9 new cases of COVID-19 bringing the total to 142 (one hundred forty-two). Health officials are conducting contact investigations.

- Arizona currently has 9,707 confirmed cases of COVID-19, resulting in 426 deaths
- Yuma County currently has 142 confirmed cases of COVID-19, resulting in 1 death
- Currently 1,344 Yuma County residents have been tested
- Currently 21 Yuma County Residents are hospitalized AS OF 8 am 05/06/20; *please note the hospitalization numbers offer an accurate “snapshot” at the time of our daily update, but numbers may fluctuate throughout the day*

### Testing Blitzes will Result in More Positive Cases:

During Sunset Health’s Testing Blitz on Saturday, May 2, there were 294 tests conducted. Sixteen (16) new positive cases were identified on just the first day of results after the blitz. More test results will be available in the days ahead, with more positive

cases anticipated.

Yuma Regional Medical Center will host the Blitz at the Yuma Civic & Convention Center, 1440 W Desert Hills Dr, Yuma, Saturday, May 9th AND next Saturday, May 16th, 8 am to 12 pm.

Sunset Health will host the Blitz in their Somerton clinic, 115 N. Somerton Ave, Somerton, May 9th, AND in their San Luis Clinic, 815 E. Cesar Chavez Blvd., San Luis, May 16, 8 am to 12 pm.

Regional Center for Border Health – Offering COVID-19 testing EVERYDAY. Testing available to anyone who may have been exposed or is experiencing the following symptoms: fever, dry cough, difficulty breathing. \*ALL insurance accepted & no one denied for inability to pay.

Somerton Location, 950 E. Main Street – Walk up & Drive Thru, Monday-Friday, 7 am – 6 pm.

San Luis Location, 1233 Main Street – Monday-Saturday, 9 am – 9 pm.

**Question of the Day: How could contact tracing help slow the spread of COVID-19?**

- Anyone who comes into close contact with someone who has COVID-19 is at increased risk of becoming infected themselves, and of potentially infecting others.
- Contact tracing can help prevent further transmission of the virus by quickly identifying and informing people who may be infected and contagious, so they can take steps to not infect others.

- Contact tracing begins with identifying everyone that a person recently diagnosed with COVID-19 has been in contact with since they became contagious. In the case of COVID-19, a person may be contagious 48 to 72 hours before they started to experience symptoms.
- The contacts are notified about their exposure. They may be told what symptoms to look out for, advised to isolate themselves for a period of time, and to seek medical attention as needed if they start to experience symptoms.

Yuma County health officials confirm “community spread” of COVID-19 throughout Yuma County. We encourage all residents to take the necessary precautions including physical distancing and staying home if you are sick. Remember to:

- Wash your hands often with soap and water for 20 seconds.
- Avoid touching your face, especially your eyes, nose, and mouth.
- Avoid people who are sick, and avoid groups of 10 people or more.
- Clean and disinfect frequently-touched surfaces like light switches, door knobs, electronic devices, etc.
- Stay home if you are sick so you do not expose others.
- Practice physical distancing, staying 6 feet away from others.
- Cover your mouth and nose with a cloth face cover when around others.

### **Arizona Department of Health Services – Communications Division**

Beginning Sunday, April 12 at noon, The AzDHS [COVID-19 in Arizona webpage](#) will include the following #COVID19 information: race and ethnicity on confirmed cases, location of confirmed cases by zip code, ages & gender of related deaths, number of hospital beds & ICU beds available, & other data points.

### **Marine Corps Air Station Yuma**

Effective April 6, 2020 and until further notice the Trusted Traveler Program is cancelled. This is an additional safety measure that #MCASYuma is taking in order to help stop the spread of #COVID19.

What this means is that essential personnel that do not have common access card (CAC) and Department of Defense (DOD) identification cards are not authorized to come aboard the base without going to the Pass and Registration office and obtaining a base access pass. Essential personnel may obtain base access by providing the appropriate paperwork to the Pass and Registration Office during working hours.

ALL VISITORS will be required to provide justification for needing access to the installation and will not be granted access to the base simply because they know someone that has a CAC or DOD identification card who will be sponsoring/escorting them aboard the base.

As of April 6, 2020, sponsoring a visitor aboard MCAS Yuma that does not have a CAC or DOD identification card is strictly prohibited unless approved at the Pass and Registration Office.

### **YUMA PROVING GROUND**

Although certain access restrictions directed by the Department of the Army are in place, Yuma Proving Ground's essential test mission in support of Army modernization priorities continues. Access to Yuma Proving Ground is currently restricted to the following:

- \*YPG residents, including Travel Camp residents
- \* YPG employees
- \* Civilian contractors who work at YPG
- \* Other personnel who come to YPG for an authorized purpose (including personnel on official orders to YPG, DoD retirees/ID card holders, and delivery drivers)
