Since March 18, 2020, the Chief Justice of the Arizona Supreme Court has issued several administrative orders in response to the COVID-19 public health threat that limited and modified court operations to ensure justice in Arizona is administered safely. The most recent such order, Administrative Order No. 2021-187, issued on December 14, 2021 directed Arizona's courts to continue to conduct business in a manner that reduced the risks associated with COVID-19 but to resume certain operations in an orderly way that prioritizes the safety of the public, judicial officers, and employees of the judiciary. This order has instructed the Presiding Superior Court Judges in each county to take steps to protect people entering courthouses and to transition to the resumption of court services.

Consistent with the content of Supreme Court Administrative Order 2021-187, Superior Court in Yuma County updates Yuma County Administrative Order 2021-07 as follows. All provisions in the aforementioned orders that are not addressed here remain in effect until further order.

IT IS ORDERED jury trials in the Superior Court are suspended through **February 11, 2022.**

IT IS FURTHER ORDERED that since all case types are now open for e-Filing, the Clerk of the Superior Court in Yuma County will no longer accept email filing.
