Gregory S. Stewart, presiding judge of the Justice of the Peace Courts in Yuma County, and that the selection procedures for this part-time position of Initial Appearance Master have previously been met,

IT IS ORDERED that Carly M. IT IS FURTHER ORDERED that Carly M. Sandoval shall be compensated for the service provided by this appointment as provided for in the Rules of Criminal Procedure, and that such compensation will be set by the Presiding Justice of the Peace.
