Pursuant to the Constitution of the State of Arizona, Article 6, Section 24, A.R.S. §12-213, and the Rules of the Arizona Supreme Court, the Arizona Supreme Court issued order R-21-0044 on November 23, 2021, amending the Rules of the Supreme Court to include Rule 96(i), which created the position of Senior Commissioner, if approved by the Chief Justice.

**IT IS ORDERED** that Chief Justice Brutinel having approved of the appointment, John N. Nelson is hereby appointed as a Senior Court Commissioner of the Superior Court in Yuma County, on a part time, as needed basis, through June 30, 2023, subject to subsequent annual reappointments by the Presiding Judge,

**IT IS FURTHER ORDERED** that John N. Nelson shall be compensated according to A.R.S. §12-213(B) and the existing compensation plan for Court Commissioners in Yuma County.

**IT IS FURTHER ORDERED** that John N. Nelson is assigned to hear and decide Criminal and Civil matters assigned to him by the Presiding Judge, or designee, without further written order.
