

**IT IS ORDERED** that JESSICA BELTRAN, Collections Specialist for the Judicial Assistance Unit, is appointed a Special Court Commissioner of the Superior Court in Yuma County for the limited purpose of examining and, if appropriate, approving requests for deferral of fees pursuant to A.R.S. §12-113(A)(3), A.R.S. §12-284, A.R.S. §12-302, and A.R.S. §12-305 and waivers of fees upon a showing by an applicant that the applicant is receiving Supplemental Security Income.
