



1           **WHEREAS** the Conciliation Court developed a Procedures Manual for the operation  
2 of Family Court Pathways Tool; and

3           Good cause appearing,

4           **IT IS HEREBY ORDERED** that a party will complete the Family Court Pathways  
5 Tool by meeting with the Court Navigator at the Yuma County Superior Court law library:

- 6           (a) Prior to or when filing or responding to an initial petition for Dissolution of Marriage  
7 with Minor Children, or  
8           (b) Prior to or when filing or responding to an initial petition for Legal Separation of  
9 Marriage with Minor Children, or  
10           (c) Prior to or when filing or responding to establish Paternity, Legal Decision-  
11 Making/Parenting Time/Child Support.

12           **IT IS FURTHER ORDERED** that the Family Court Pathways Tool will not be  
13 completed when:

- 14           (a) One or both parties are represented by an attorney, or  
15           (b) There are post-decree actions.

16           **IT IS FURTHER ORDERED** that the Family Court Pathways Tool:

- 17           (a) Will be directly submitted to Professor O'Hara and the pilot assignment team  
18 managed by Professor O'Hara;  
19           (b) Must not be retained in the case file;  
20           (c) Must not contain personal identifiers;  
21           (d) Is not subject to Rule 123, Rules of Arizona Supreme Court; and  
22           (e) Must be destroyed in accord with the Memorandum of Understanding governing this  
23 pilot project.

24           **IT IS FURTHER ORDERED** that the pilot project shall run for a period not to  
25 exceed 36 months, effective November 3, 2025.
